Chamber Executive Director Attends LABOUR FORCE SHORTAGE SEMINAR

The Saskatchewan Labour Work and Family Unit held a Work-Family Balance & Labour Force Shortage seminar on March 13th and 14th in Saskatoon and I attended hoping to gain some insight for myself and our membership on the urgent issue of Labour Shortage.

Where are we going to find employees and how do we keep the employees we have were the two main themes that resonated through out each part of the seminar. A work force sits right under our noses and we have talked about it, and acknowledged it for some time but engaging it is the issue. That work force is the Aboriginal population. Other sources we don't hear as much about are; Stay at home Mothers whose kids are now in school, immigration, Youth, Seniors who wish to work past retirement, and technology lay offs. Each source can bring us workers but we may have to be more open to their needs to get them and keep them.

Family Friendly workplaces are where the business world needs to go to retain their staff and attract new workers. Characteristics of a Family Friendly workplace are; Flexibility, Supportive Supervisors/Managers, A culture that is Family Friendly, Alternative Work Arrangements, Recognition of Child and Elder Care Issues, were at the top of the list. Some of the presenters at the seminar were Dr. Suzan Lewis a Professor from Middlesex University Business School, on not easy but doable, working towards real, sustained change in workplace structure, Rosemary Venne, PhD on the coming demographic shifts and a host of business panels on what they are doing, including Yorkton's Corvyn Neufeld with Cornerstone Credit Union just to name a few.

Our Youth today are in a position to have jobs abundant, and will hold bosses to their word. It is said that Youth today do not leave a bad job they leave a bad Manager. Why stay? That is the big challenge of today. If they are not treated with respect, kindness, equality and more they can just go down the street for another job. Us Boomers did not have that luxury and stayed at our jobs no matter what. We got more education to get the better jobs and we brought our kids up with the University bug. Now our Youth are getting job after job right out of High School or even in High School. Not to say these jobs are the careers they will stay with, but Trades, Oil fields and high paying laborers are the call to our Youth today. We are at the turning point where we need to rethink our employment practices to not only attract but to keep our workers.

Small Business has always known about the need to be Family Friendly and the Policy and Procedure manual is not the first thing on the list when you are starting your business. If my only other staff needs to bring her sick child in or stay home with him, I defiantly will work around it to keep her. Stay at home Mothers whose children are now in school are scared to come back to work because of training and still wanting to be at home with the kids after school. This is easily fixed with a 9-3 shift and the offer of on the job training. There is ways around the issues and Small Business practices can give the larger corporations a helping hand when it comes to ideas. As the large Corporations can and have led the way with Policy. There is no one way fits all and this message is equally important in small and big business.

At the seminar I did see a lack of Small Business representatives, as it is harder for a one or two person operation to leave their business.
